



TOWNSHIP OF OLD BRIDGE (1215) Descriptions of New Ward Boundaries January 2022

The following data resources were provided by the NJDEP Stream centerlines 2015; NJDOT Street centerlines 2015; TeleAtlas Street centerlines 2010. The parcels (2021) were provided and referenced as the interpretation made by the New Jersey Geographic Information Network (NJGIN). The municipal boundaries 2021, were provided and referenced as the interpretation made by the NJ Office of GIS. This source data was utilized for the preparation of the ward district word description as stipulated under N.J.S.A. 40:44-15 (L. 1981, c. 496, s. 7, eff. Jan. 12, 1982) for submission to the Office of the New Jersey Secretary of State (SOS).

The Township of Old Bridge in the County of Middlesex in the State of New Jersey is comprised of a total of Six (6) Wards. Due to population changes and other concerns documented during Census 2020, new boundaries for these wards are required to meet Title 40, 40A (Municipalities, Counties) guidelines and the Township's current needs. The new boundaries for these wards are described herein.

Ward One

The First Ward of the Township of Old Bridge shall include all of the territory and inhabitants thereof contained, in an area which is bounded and described as follows:

Beginning at a point where the physical centerline of the New Jersey State Highway No. 34 is intersected by a point on the Township of Old Bridge, Middlesex County and the Borough of Matawan, Monmouth County shared border;

Thence, Westerly, following along the physical centerline of the New Jersey State Highway No. 34 from the Township of Old Bridge, Middlesex County and the Borough of Matawan, Monmouth County shared border, to a point where said boundary intersects the physical centerline of Disbrow Avenue;

Continue, Southerly, following along the physical centerline of Disbrow Avenue, to a point where said boundary intersects the physical centerline of Lambertson Road;

Thence, Southwesterly, various courses, following along the physical centerline of Lambertson Road, crossing over the physical centerline of Amboy Road (County Route 689), to a point where said boundary intersects the physical centerline of Farrington Road;

Thence, Northwesterly, following along the physical centerline of Farrington Road, to a point where said boundary is intersected by the centerline of Tennent Brook (a waterway);

Thence, Westerly, various courses, following along the centerline of Tennent Brook (a waterway), to a point where said boundary is intersected by the physical centerline of Cottrell Road (County Route 687);

Thence, North, following along the physical centerline of Cottrell Road (County Route 687), to a point where said boundary intersects the physical centerline of Spring Hill Road (County Route 699);

Thence, Northwest, following along the physical centerline of Spring Hill Road (County Route 699), to a point where said boundary intersects the physical centerline of Old Mill Road;

Ward One (cont'd)

Thence, Easterly, following along the physical centerline of Old Mill Road, to a point where said boundary is intersected by the physical centerline of Dock Road (a.k.a. Steamboat Landing) and the physical centerline of the New Jersey State Highway No. 34;

Thence, Northerly, various courses, following along the physical centerline of Dock Road (a.k.a. Steamboat Landing), to a point where said boundary intersects the centerline of Cheesequake Creek (a waterway);

Thence, Northwardly, various courses, following along the centerline of Cheesequake Creek (a waterway), crossing over the centerline of the Cheesequake Creek tributary (a waterway), to a point where said boundary intersects with a point on the Township of Old Bridge, Middlesex County and the Borough of Sayreville, Middlesex County shared border;

Thence, Northeasterly then Southeasterly, various courses, following along the Township of Old Bridge, Middlesex County and the Borough of Sayreville, Middlesex County shared border, crossing over the physical centerline of the Garden State Parkway and then crossing over the physical centerline of the New Jersey State Highway No. 35, to a point on the Township of Old Bridge, Middlesex County and the Township of Aberdeen, Monmouth County shared border;

Continue, Southeasterly then Southwesterly, various courses, following along the Township of Old Bridge, Middlesex County and the Township of Aberdeen, Monmouth County shared border, crossing over the physical centerline of the New Jersey State Highway No. 35 then crossing over the physical centerline of the Garden State Parkway, to another point on the Township of Old Bridge, Middlesex County and the Borough of Matawan, Monmouth County shared border, which is also the point of beginning.

Ward Two

The Second Ward of the Township of Old Bridge shall include all of the territory and inhabitants thereof contained, in an area which is bounded and described as follows:

Beginning at a point where the physical centerline of the New Jersey State Highway No. 18 is intersected by a point on the Township of Old Bridge, Middlesex County and the Township of Marlboro, Monmouth County shared border;

Thence, Northwest, following along the physical centerline of the New Jersey State Highway No. 18, to a point where said boundary intersects with the physical centerline of the New Jersey State Highway Route 9;

Thence, Northerly, following along the physical centerline of the New Jersey State Highway Route 9, to a point where said boundary is intersected by the physical centerline of Ferry Road;

Thence, Southeasterly, following along the physical centerline of Ferry Road, to a point where said boundary intersects the physical centerline of Oakland Road;

Thence, Northeastwardly, various courses, following along the physical centerline of Oakland Road, to a point where said boundary intersects the physical centerline of Norman Lane;

Thence, Easterly, following along the physical centerline of Norman Lane, to a point where said boundary is intersected by the physical centerline of Morningside Drive;

Ward Two (cont'd)

Thence, Northeasterly, following along the physical centerline of Morningside Drive, to a point where said boundary is intersected by the physical centerline of Cymbeline Drive;

Continue, Southeasterly, following along the physical centerline of Cymbeline Drive, to a point where said boundary intersects the physical centerline of Prest's Mill Road;

Thence, Northerly, following along the physical centerline of Prest's Mill Road, to its point of intersection with the physical centerline of Cressida Drive;

Continue, Easterly, following along the physical centerline of Cressida Drive, to its point of intersection with the physical centerline of Troilus Drive;

Thence, Northerly, following along the physical centerline of Troilus Drive, to another point of intersection with the physical centerline of Prest's Mill Road;

Thence, Northerly, following along the physical centerline of Prest's Mill Road, to its point of intersection with the physical centerline of Ticetown Road;

Thence, Westerly, following along the physical centerline of Ticetown Road, to its point of intersection with the physical centerline of Cottrell Road (County Route 687);

Thence, Northerly, following along the physical centerline of Cottrell Road (County Route 687), crossing over the physical centerline of Old Bridge Matawan Road (County Route 516), to its point of intersection with the centerline of Cheesequake Brook (a waterway);

Thence, Easterly, various courses, following along the centerline of Cheesequake Brook (a waterway), to its point of intersection with the physical centerline of Farrington Road;

Thence, Southeast, following along the physical centerline of Farrington Road, to its point of intersection with the physical centerline of Lambertson Road;

Thence, Northeast, following along the physical centerline of the Lambertson Road, crossing over the physical centerline of Amboy Road (County Route 689), to its point of intersection with the physical centerline of the New Jersey State Highway No. 34;

Thence, Southeast, following along the physical centerline of the New Jersey State Highway No. 34, to its point of intersection with the Township of Old Bridge, Middlesex County and the Borough of Matawan, Monmouth County shared border;

Thence, Southerly, various courses, following along the Township of Old Bridge, Middlesex County and the Borough of Matawan, Monmouth County shared border, to a point where said boundary intersects with the Township of Old Bridge, Middlesex County and the Township of Aberdeen, Monmouth County shared border;

Thence, Southwesterly, various courses, following along the Township of Old Bridge, Middlesex County and the Township of Aberdeen, Monmouth County shared border, to a point where said boundary intersects with the physical centerline of the New Jersey State Highway No. 18, which is also another point on the Township of Old Bridge, Middlesex County and the Township of Marlboro, Monmouth County shared border and is also the point of beginning.

Ward Three

The Third Ward of the Township of Old Bridge shall include all of the territory and inhabitants thereof contained, in an area which is bounded and described as follows:

Beginning at a point where the centerline of the Cheesequake Brook (a waterway) is intersected by a point on the Township of Old Bridge, Middlesex County and the Borough of Sayreville, Middlesex County shared border;

Thence, Southwesterly, various courses, following along the centerline of the Cheesequake Brook (a waterway), crossing over the centerline of the Cheesequake Brook tributary (a waterway), to a point where said boundary intersects the physical centerline of Dock Road (a.k.a. Steamboat Landing);

Continue, Southwesterly, various courses, following along the physical centerline of Dock Road (a.k.a. Steamboat Landing), to a point where said boundary intersects with the physical centerline of Old Mill Road;

Thence, Westerly, following along the physical centerline of Old Mill Road, to a point where said boundary intersects with the physical centerline of Spring Hill Road (County Route 699);

Thence, Southeast, following along the physical centerline of Spring Hill Road (County Route 699), to a point where said boundary intersects with the physical centerline of Jake Brown Road;

Thence, Southwest, following along the physical centerline of Jake Brown Road, to a point where said boundary intersects with the physical centerline of the New Jersey State Highway Route 9;

Thence, Northerly, following along the physical centerline of the New Jersey State Highway Route 9, to a point where said boundary intersects with the physical centerline of Perrine Road;

Thence, Easterly, various courses, following along the physical centerline of Perrine Road, to a point where said boundary intersects with the physical centerline of the Cheesequake Road;

Thence, Northerly, following along the physical centerline of Cheesequake Road, to a point where said boundary intersects with the physical centerline of Water Works Road;

Thence, Easterly, following along the physical centerline of Water Works Road, to a point where said boundary intersects with the physical centerline of the Unnamed Road;

Thence, Northwest, following along the physical centerline of the Unnamed Road, to a point where said boundary intersects with the physical centerline of Bordentown-South Amboy Turnpike;

Thence, Northwest, following along the physical centerline of Bordentown-South Amboy Turnpike, to another point on the Township of Old Bridge, Middlesex County and the Borough of Sayreville, Middlesex County shared border;

Thence, Northerly, following along the physical centerline of Bordentown-South Amboy Turnpike, which is also the Township of Old Bridge, Middlesex County and the Borough of Sayreville, Middlesex County shared border, to a point where said boundary intersects with the physical centerline of Ernston Road, which is also the Township of Old Bridge, Middlesex County and the Borough of Sayreville, Middlesex County shared border;

Ward Three (cont'd)

Thence, Southeasterly, following along the Township of Old Bridge, Middlesex County and the Borough of Sayreville, Middlesex County shared border, crossing over the physical centerline of the New Jersey State Highway Route 9, to a point where said boundary intersects with the centerline of the Cheesequake Brook (a waterway), which is also another point on the Township of Old Bridge, Middlesex County and the Borough of Sayreville, Middlesex County shared border and the point of beginning.

Ward Four

The Fourth Ward of the Township of Old Bridge shall include all of the territory and inhabitants thereof contained, in an area which is bounded and described as follows:

Beginning at a point where the physical centerline of Bordentown-South Amboy Turnpike is intersected by the point on the Township of Old Bridge, Middlesex County and the Borough of Sayreville, Middlesex County shared border;

Thence, Southeast, following along the physical centerline of the Bordentown-South Amboy Turnpike, which is also a point on the Township of Old Bridge, Middlesex County and the Borough of Sayreville, Middlesex County shared border, to a point where said boundary intersects the physical centerline of the Unnamed Road;

Continue, Southeast, following along the physical centerline the Unnamed Road, to a point where said boundary intersects the physical centerline of Water Works Road;

Thence, Easterly, following along the physical centerline Water Works Road, to a point where said boundary intersects the physical centerline of Cheesequake Road;

Thence, Southerly, following along the physical centerline Cheesequake Road, to a point where said boundary intersects the physical centerline of Perrine Road;

Thence, Easterly, following along the physical centerline Perrine Road, to a point where said boundary intersects the physical centerline of the New Jersey State Highway Route 9;

Thence, Southerly, following along the physical centerline the New Jersey State Highway Route 9, to a point where said boundary intersects the physical centerline of Jake Brown Road;

Thence, Northeast, following along the physical centerline of Jake Brown Road, to a point where said boundary intersects the physical centerline of Cottrell Road (County Route 687);

Thence, Southwardly, following along the physical centerline of Cottrell Road (County Route 687), crossing over the physical centerline of Old Bridge Matawan Road (County Route 516), to a point where said boundary is intersected by the physical centerline of Ticetown Road;

Thence, Easterly, following along the physical centerline of Ticetown Road, to its point of intersection with the physical centerline of Prest's Mill Road;

Thence, Southerly, following along the physical centerline of Prest's Mill Road, to another point of intersection with the physical centerline of Troilus Drive;

Ward Four (cont'd)

Continue, Easterly then Southerly, following along the physical centerline of Troilus Drive, to its point of intersection with the physical centerline of Cressida Drive;

Thence, Easterly, following along the physical centerline of Cressida Drive, to another point of intersection with the physical centerline of Prest's Mill Road;

Continue, Southwesterly, following along the physical centerline of Prest's Mill Road, to a point where said boundary intersects the physical centerline of Cymbeline Drive;

Thence, Northwesterly, following along the physical centerline of Cymbeline Drive, to a point where said boundary is intersected by the physical centerline of Morningside Drive;

Thence, Westerly, following along the physical centerline of Morningside Drive, to a point where said boundary is intersected by the physical centerline of Norman Lane;

Thence, Southwesterly, following along the physical centerline of Norman Lane, to a point where said boundary intersects the physical centerline of Oakland Road;

Thence, Southwesterly, various courses, following along the physical centerline of Oakland Road, to a point where said boundary intersects the physical centerline of Ferry Road;

Thence, Northwest, following along the physical centerline of Ferry Road, to a point where said boundary is intersected by the physical centerline of the New Jersey State Highway Route 9;

Thence, Northeast, following along the physical centerline of the New Jersey State Highway No. 9, to a point where said boundary intersects with the physical centerline of Cindy Street;

Thence, Westerly, following along the physical centerline of Cindy Street, to a point where said boundary is intersected by the physical centerline of Grace Drive;

Thence, Northerly, following along the physical centerline of Grace Drive, to a point where said boundary is intersected by the physical centerline of Throckmorton Lane;

Continue, West, following along the physical centerline of Throckmorton Lane, to a point where said boundary is intersected by the physical centerline of Saul Place;

Thence, North, following along the physical centerline of Saul Place, to a point where said boundary intersects the physical centerline of Alpha Avenue;

Thence, West, following along the physical centerline of Alpha Avenue, to a point where said boundary is intersected by the physical centerline of Buttonwood Drive;

Continue, Northerly, following along the physical centerline of Buttonwood Drive, to a point where said boundary is intersected by the physical centerline of Gaub Road;

Thence, South, following along the physical centerline of Gaub Road, to another point where said boundary is intersected by the physical centerline of Throckmorton Lane;

Ward Four (cont'd)

Thence, East, following along the physical centerline of Throckmorton Lane, to a point where said boundary intersects the physical centerline of Utica Road;

Continue, East, following along the physical centerline of Utica Road, to another point where said boundary intersects the physical centerline of Cindy Street;

Thence, South, following along the physical centerline of Cindy Street, to a point where said boundary intersects the physical centerline of Par Avenue;

Thence, West, following along the physical centerline of Par Avenue, to a point where said boundary intersects the extended centerline of a utility easement, which is also a point on the tax assessment property line of block 15000, lot(s) 13;

Thence, Northwesterly, following along the centerline of a utility easement, crossing over the tax assessment property line of block 15000, lot(s) 13, from the physical centerline of Par Avenue to a point where said boundary intersects the centerline of Deep Run (a waterway);

Thence, Northwesterly, various courses, following along the centerline of Deep Run (a waterway), crossing over the physical centerline of Old Bridge Matawan Road (County Route 516), which then crosses over the centerline of several Deep Run tributaries (waterways), to a point where said boundary intersects the physical centerline of Bordentown Avenue, which is also another point on the Township of Old Bridge, Middlesex County and the Borough of Sayreville, Middlesex County shared border;

Thence, Northeasterly, following along the physical centerline of Bordentown Avenue, which transitions into the physical centerline of Bordentown-South Amboy Turnpike and is also the Township of Old Bridge, Middlesex County and the Borough of Sayreville, Middlesex County shared border, to a point where said boundary intersects the physical centerline of the Unnamed Road, which is also the point of beginning.

Ward Five

The Fifth Ward of the Township of Old Bridge shall include all of the territory and inhabitants thereof contained, in an area which is bounded and described as follows:

Beginning at a point where the physical centerline of Englishtown Road (County Route 527) is intersected by the centerline of the Matchaponix River (a waterway), which is also a point on the Township of Old Bridge, Middlesex County and the Township of Monroe, Middlesex County shared border;

Thence, Northerly, following along the physical centerline Englishtown Road (County Route 527), crossing over the physical centerline of Texas Road (County Route 520), to a point where said boundary intersects the centerline of the J.C.P.& L. Co. R.O.W.;

Thence, East then North, following along the centerline of the J.C.P.& L. Co. R.O.W., crossing over the tax assessment property line of block 19001, lot(s) 170.11, to a point where said boundary intersects the physical centerline of Birch Street;

Thence, Northeast, following along the physical centerline of Birch Street, to a point where said boundary intersects the centerline of Iresick Brook (a waterway);

Ward Five (cont'd)

Thence, Southwardly, various courses, following along the centerline of Iresick Brook (a waterway), to a point where said boundary intersects the physical centerline of Pleasant Valley Road;

Thence, Southeast, following along the physical centerline of Pleasant Valley Road, to a point where said boundary intersects the physical centerline of Marlboro Road;

Thence, Northeast, following along the physical centerline of Marlboro Road, to a point where said boundary intersects the physical centerline of the New Jersey State Highway No. 18;

Thence, Northwest, following along the physical centerline of the New Jersey State Highway No. 18, to a point where said boundary intersects the physical centerline of Farmbrook Drive;

Thence, Northerly, following along the physical centerline of Farmbrook Drive, to a point where said boundary intersects the physical centerline of Orchard Drive;

Thence, Easterly, following along the physical centerline of Orchard Drive, to a point where said boundary intersects the physical centerline of Longview Road;

Thence, Northeasterly, following along the physical centerline of Longview Road, to a point where said boundary intersects the physical centerline of Stoneybrook Drive;

Thence, Westerly, following along the physical centerline of Stoneybrook Drive, to a point where said boundary intersects the physical centerline of Southwood Drive;

Thence, Northerly, following along the physical centerline of Southwood Drive, to a point where said boundary intersects the physical centerline of Sunrise Road;

Thence, Northeast, following along the physical centerline of Sunrise Road, to a point where said boundary intersects the physical centerline of Old Bridge Matawan Road (County Route 516);

Thence, Easterly, following along the physical centerline of Old Bridge Matawan Road (County Route 516), to a point where said boundary intersects the centerline of Deep Run (a waterway);

Thence, Southerly, various courses, following along the centerline of Deep Run (a waterway), to a point where said boundary intersects the centerline of a utility easement, which is also a point on the tax assessment property line of block 15000, lot(s) 13;

Thence, Easterly, following along the centerline of a utility easement, crossing over the tax assessment property line of block 15000, lot(s) 13, to a point where said boundary intersects the extended physical centerline of Par Avenue;

Thence, Easterly, following along the physical centerline of Par Avenue, from the centerline of a utility easement, crossing over the tax assessment property line of block 15000, lot(s) 13, to a point where said boundary intersects the extended physical centerline of Cindy Street;

Continue, East, following along the physical centerline of Cindy Street, to another point where said boundary intersects the physical centerline of Utica Road;

Ward Five (cont'd)

Thence, Easterly, following along the physical centerline of Utica Road, to a point where said boundary intersects the physical centerline of Throckmorton Lane;

Continue, Easterly, following along the physical centerline of Throckmorton Lane, to another point where said boundary is intersected by the physical centerline of Gaub Road;

Continue, Northerly, following along the physical centerline of Gaub Road, to a point where said boundary is intersected by the physical centerline of Buttonwood Drive;

Thence, Southwesterly, following along the physical centerline of Buttonwood Drive, to a point where said boundary is intersected by the physical centerline of Alpha Avenue;

Thence, East, following along the physical centerline of Alpha Avenue, to a point where said boundary intersects the physical centerline of Saul Place;

Continue, South, following along the physical centerline of Saul Place, to another point where said boundary is intersected by the physical centerline of Throckmorton Lane;

Thence, Easterly, following along the physical centerline of Throckmorton Lane, to a point where said boundary is intersected by the physical centerline of Grace Drive;

Thence, Southerly, following along the physical centerline of Grace Drive, to a point where said boundary is intersected by the physical centerline of Cindy Street;

Thence, Easterly, following along the physical centerline of Cindy Street, to a point where said boundary intersects with the physical centerline of the New Jersey State Highway No. 9;

Thence, Southerly, following along the physical centerline of the New Jersey State Highway No. 9, to a point where said boundary intersects with the physical centerline of the New Jersey State Highway No. 18;

Thence, Southeasterly, following along the physical centerline of the New Jersey State Highway No. 18, to a point where said boundary intersects with the Township of Old Bridge, Middlesex County and the Township of Marlboro, Monmouth County shared border;

Thence, Southwesterly, following along the Township of Old Bridge, Middlesex County and the Township of Marlboro, Monmouth County shared border, from the physical centerline of the New Jersey State Highway No. 18 to a point where said boundary intersects with the Township of Old Bridge, Middlesex County and the Township of Manalapan, Monmouth County shared border;

Continue, Southwesterly, following along the Township of Old Bridge, Middlesex County and the Township of Manalapan, Monmouth County shared border, to a point where said boundary intersects with the centerline of the Matchaponix River (a waterway), which is also the Township of Old Bridge, Middlesex County and the Township of Monroe, Middlesex County shared border;

Thence, Northwesterly, various courses, following along the centerline of the Matchaponix River (a waterway), which is also the Township of Old Bridge, Middlesex County and the Township of Monroe, Middlesex County shared border, to a point where said boundary intersects with the physical centerline of Englishtown Road (County Route 527), which is also another point on the Township of Old Bridge, Middlesex County and the Township of Monroe, Middlesex County shared border and the point of beginning.

Ward Six

The Sixth Ward of the Township of Old Bridge shall include all of the territory and inhabitants thereof contained, in an area which is bounded and described as follows:

Beginning at a point where the physical centerline of Englishtown Road (County Route 527) is intersected by the centerline of the Matchaponix River (a waterway), which is also a point on the Township of Old Bridge, Middlesex County and the Township of Monroe, Middlesex County shared border;

Thence, Northerly, various courses, following along the centerline of the Matchaponix River (a waterway), which transitions into the South River (a waterway) and is also the Township of Old Bridge, Middlesex County and the Township of Monroe, Middlesex County shared border, to a point where said boundary intersects with a point on the Township of Old Bridge, Middlesex County and the Borough of Spotswood, Middlesex County shared border;

Thence, Northeasterly, various courses, following along the centerline of the South River (a waterway), which is also the Township of Old Bridge, Middlesex County and the Borough of Spotswood, Middlesex County shared border, to a point where said boundary intersects with a point on the Township of Old Bridge, Middlesex County and the Township of East Brunswick, Middlesex County shared border;

Thence, Easterly, various courses, following along the centerline of the South River (a waterway), which is also the Township of Old Bridge, Middlesex County and the Borough of Spotswood, Middlesex County shared border, to a point where said boundary intersects with a point on the Township of Old Bridge, Middlesex County and the Township of East Brunswick, Middlesex County shared border;

Continue, Easterly then Northerly, various courses, following along the centerline of the South River (a waterway), which is also the Township of Old Bridge, Middlesex County and the Township of East Brunswick, Middlesex County shared border, crossing over the physical centerline of the New Jersey State Highway No. 18, to a point where said boundary intersects with the physical centerline of the Bordentown-South Amboy Turnpike, which is also a point on the Township of Old Bridge, Middlesex County and the Borough of Sayreville, Middlesex County shared border;

Thence, Northeast, following along the physical centerline of the Bordentown-South Amboy Turnpike, which is also the Township of Old Bridge, Middlesex County and the Borough of Sayreville, Middlesex County shared border, to a point where said boundary intersects with the centerline of Deep Run (a waterway);

Thence, Southeasterly, various courses, following along the centerline of Deep Run (a waterway), crossing over the centerline of several Deep Run tributaries (waterways), to a point where said boundary intersects the physical centerline of Old Bridge Matawan Road (County Route 516);

Thence, Northwest, following along the physical centerline of Old Bridge Matawan Road (County Route 516), to a point where said boundary intersects the physical centerline of Sunrise Road;

Thence, Southwest, following along the physical centerline of Sunrise Road, to a point where said boundary intersects the physical centerline of Southwood Drive;

Thence, Southerly, following along the physical centerline of Southwood Drive, to a point where said boundary intersects the physical centerline of Stoneybrook Drive;

Thence, Southwesterly, following along the physical centerline of Stoneybrook Drive, to a point where said boundary intersects the physical centerline of Longview Road;

Ward Six (cont'd)

Thence, Westerly, following along the physical centerline of Longview Road, to a point where said boundary intersects the physical centerline of Orchard Drive;

Thence, Southerly, following along the physical centerline of Orchard Drive, to a point where said boundary intersects the physical centerline of Farmbrook Drive;

Thence, Southwest, following along the physical centerline of Farmbrook Drive, to a point where said boundary intersects the physical centerline of the New Jersey State Highway No. 18;

Thence, Southeast, following along the physical centerline of the New Jersey State Highway No. 18, to a point where said boundary intersects the physical centerline of Marlboro Road;

Thence, Southwest, following along the physical centerline of Marlboro Road, to a point where said boundary intersects the physical centerline of Pleasant Valley Road;

Thence, Northwest, following along the physical centerline of Pleasant Valley Road, to a point where said boundary intersects the centerline of Iresick Brook (a waterway);

Thence, Northwardly, various courses, following along the centerline of Iresick Brook (a waterway), to a point where said boundary intersects the physical centerline of Birch Street;

Thence, Southwest, following along the physical centerline of Birch Street, to a point where said boundary intersects the centerline of the J.C.P.& L. Co. R.O.W.;

Thence, Southerly then Southwesterly, following along the centerline of the J.C.P.& L. Co. R.O.W., physical centerline Englishtown Road (County Route 527), crossing over the tax assessment property line of block 19001, lot(s) 170.11, to a point where said boundary intersects the centerline of the Matchaponix River (a waterway), which is also a point on the Township of Old Bridge, Middlesex County and the Township of Monroe, Middlesex County shared border and the point of beginning.

The Township of Old Bridge is currently located in Legislative District Twelve and is split between Congressional District Six and Congressional District Twelve.
