Tonight's honoree is the recycling coordinator from Sayreville, Elise Barone. Ms. Barone is described as a hard-working, staunch supporter of recycling in her community. She has been with the Borough for over 20 years and has worked the recycling department for 11 or more years. Ms. Barone has received awards from NJ Clean Communities Council and is an asset to MCIA. Elise Barone thanks Executive Directors Polos for his nice words and award. She also comments on how wonderful it has been working with MCIA staff, especially Christy.
