### 9. APPROVAL OF MINUTES

a) Motion for approval of the Minutes of the Agenda Session and Regular Meeting of April 13, 2022 made by Commissioner D'Agostino, seconded by Commissioner Abbey. Approved by unanimous vote.

### 10. PUBLIC COMMENTS ON RESOLUTIONS

Charlie Kratovil from New Brunswick inquires with reference to 8(a) whether the parking facility is turning a profit or losing money. Executive Director Polos answers (after resolving some technical microphone issues) that the MCIA anticipates a revenue of \$427,000 and expenses of \$313,000 for the parking deck and that a Resolution was submitted to the state for budget purposes.

Charlie Kratovil acknowledges he does not have any more comments on resolutions but does ask about the virtual nature of the meeting. He states he cannot get in the meeting

using Zoom, that he gets rejected when he tries. He asks whether the Board members are on Zoom and whether they can see each other. Chairman Nolan informs Mr. Kratovil that no members are on video, they are just on audio. Mr. Kratovil further comments that he believes if the MCIA members are able to get on Zoom, the public should be able to as well. Chairman Nolan advises he will look into the technical aspect of this issue.

### 12. PAYMENT OF VOUCHERS

### 13. PUBLIC SESSION

Charlie Kratovil inquires as to the any updates on the school construction in New Brunswick. Mr. Kratovil states he spoke with the BOE and was told they were supposed to get the structural steel in April but he did not see any when he drove by the site yesterday. He then asks whether there is an update on the timeline of the new school. Chairman Nolan advises that General Counsel has changed and needs time to get up to speed on the current status. Executive Director Polos also advises he has no update. Chairman Nolan states he will try to have an update for the next meeting. Mr. Kratovil voices his concerns that the monthly updates from Devco are no longer being made on a regular basis. Mr. Kratovil mentions a fire yesterday at 986 Jersey Ave., Solterra Recycling Facility in New Brunswick, and asks whether anyone has any information on the fire and whether the fire has impacted the MCIA's business. Executive Director Polos advises that he is not aware of that fire in New Brunswick and that the MCIA has not been advised that there is any impact to its service.

## RESOLUTION OF THE MIDDLESEX COUNTY IMPROVEMENT AUTHORITY AUTHORIZING PROCUREMENT OF INSURANCE COVERAGE FOR ROOSEVELT CARE CENTER FACILITIES FOR THE PERIOD JUNE 1, 2022 – MAY 31, 2023

WHEREAS, a regular meeting of the Middlesex County Improvement Authority (the "Authority") was held on May 11, 2022; and

WHEREAS, pursuant to N.J.S.A. 40:37A-55(t), the Authority is authorized to enter into any and all agreements or contracts, execute any and all instruments, and do and perform any and all acts or things necessary, convenient or desirable for the purposes of the Authority subject to the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq.; and

WHEREAS, the Authority operates the long-term care facilities Roosevelt Care Center at Old Bridge and Roosevelt Care Center and Edison; ("Roosevelt Care Center"); and

WHEREAS, the Authority requires certain healthcare professional and general liability insurance (the "Insurance") for Roosevelt Care Center; and

WHEREAS, the procurement of Insurance is an exception to the bidding requirements of the Local Public Contracts Law as an Extraordinary Unspecifiable Service pursuant to (N.J.S.A 40A:11-5(i)(a)(ii) and N.J.A.C. 5:34-2.3(b); and

WHEREAS, the Certifying Finance Officer has certified that the value of the contract will exceed \$17,500.00; and

WHEREAS, the Authority's insurance producer solicited quotes for the provision of the Insurance from a number of carriers and recommends procurement of the Insurance from TDC for Professional and General Liability and from Starstone for Excess Liability through its managing underwriter, AB Risk; and

WHEREAS, the Authority would like to authorize the procurement of the Insurance for Roosevelt Care Center in accordance with this Resolution.

## NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE MEMBERS OF THE MIDDLESEX COUNTY IMPROVEMENT AUTHORITY AS FOLLOWS:

1. The Authority authorizes the procurement of the Insurance from TDC and Starstone through its managing underwriter, AB Risk through Acrisure, LLC (North American Insurance Management) at a cost not to exceed \$660,000.00. The Authority authorizes consideration of the

voucher or payment requisition for the payment of the Insurance simultaneously with the consideration of this Resolution.

- 2. The Authority authorizes the Chief Financial Officer to take any and all acts reasonable and necessary to bind the coverage, including, but not limited to, execution of any contracts or applications and hereby ratifies and confirms any action heretofore taken by the Chief Financial Officer in connection therewith.
- 3. The Secretary shall be and is hereby directed to cause a brief notice of the authorization to be printed as required by N.J.S.A. 40A:11-5(l)(a)(ii).
- 4. The Certifying Finance Officer has certified that the funds for the Insurance are available from and can be obtained from the funds of the Authority.
