# BOARD OF ELECTIONS POST-ELECTION MAIL-IN BALLOT AND PROVISIONAL BALLOT HEARING JUNE 13, 2022

The Post-Election Mail-in Ballot and Provisional Ballot Hearing of the Middlesex County Board of Elections was called to order by Chairman Engel at 4:00 p.m. Flag salute followed.

The Board determined that if the vote is identical on both the ballot card and the paper provisional ballot, one vote could be counted. Motion was made by Comm. Katz to accept one ballot. Motion was seconded by Comm. Frankel. Voice vote 5-0.

Motion was made by Comm. Katz to reject all the provisional ballots in the categories listed. Motion was seconded by Comm. Frankel. Voice vote 5-0.

- Piscataway Senior Center The paperwork was not filled out properly. The bag was not sealed. Motion was made by Comm. Jalloh to reject the ballots. Motion was seconded by Comm. Moskowitz. Voice vote 5-0.
