a) Recycling: Executive Director Polos advises that the recycling level has picked up, staffing levels have improved with the vendor, and the number of misses has dropped dramatically.

- a) Morris Cancer Center: Structural steel is at the 9th level of the building with completion of steel projected by mid-November. Contractors poured concrete up to the 4th level. Sprayed fireproofing was commenced on the lower levels. The parking garage the MCIA is responsible for cast and concrete continues on the lower level of the garage and the installation of the pre-cast panels for the garage is expected to commence at the end of November.
- b) Valenti School: Exterior framing is well underway, roofing has commenced, elevator shafts are underway and they still have a projected completion date of August 2023.
- c) Train Station: Completed 10% design, received minor comments from transit regarding submission, the Design Phase Agreement with Amtrak is completed; well into 30% design of the project, and things are moving ahead very swiftly.

## RESOLUTION OF THE MIDDLESEX COUNTY IMPROVEMENT AUTHORITY AUTHORIZING CHANGE ORDER #1 TO CONTRACT FOR CURBSIDE RECYCLING

WHEREAS, a regular meeting of the Middlesex County Improvement Authority (the "Authority") was held on September 14, 2022; and

WHEREAS, pursuant to N.J.S.A. 40:37A-55(t), a county improvement authority is empowered to enter into any and all contracts, execute any and all instruments and do and perform any and all acts or things necessary, convenient or desirable for the purposes of the Authority or to carry out any power given in the County Improvement Authorities Law, N.J.S.A. 40:37A-44, et seq., subject to the "Local Public Contracts Law," N.J.S.A. 40A:11-1 et seq.; and

WHEREAS, the Authority prepared and issued a bid specification package, advertised for bids for Curbside Recycling Services in Middlesex County with participating municipalities and received bids; and

WHEREAS, by Resolution # 19-151 duly adopted by the Authority on November 13, 2019, the Authority awarded a three-year contract for curbside recycling to Central Jersey Waste as the lowest responsive, responsible bidder received for the Service; and

WHEREAS, Resolution #19-151 awarded a total not exceed amount of \$6,908,776.32 annually; and

WHEREAS, a change order to the contract with Central Jersey Waste is required due to an increase in the number of new construction units and the addition of new municipalities to the program, as allowed for by the contract specifications, and as authorized by N.J.A.C. 5:30-11.3(9); and

WHEREAS, the value of the remaining 2022 and 2023 contract has increased due to the large number of units to be serviced by the Central Jersey Waste; and

WHEREAS, the Authority would like to authorize a change order to the contract with Central Jersey Waste to provide for the increase in the number of units and municipalities being added to the program in excess of previously anticipated increases; and

WHEREAS, due to the increase in the number of monthly base units to be serviced by Central Jersey Waste, it is necessary to increase the annual not to exceed amount to \$8,290,532.58 annually, an increase of 20%; and

WHEREAS, the Authority would like to approve change order #1 to increase the budget of the curbside recycling for the remainder of contract which is a portion of year 2022 and 2023;

### NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE MEMBERS OF THE MIDDLESEX COUNTY IMPROVEMENT AUTHORITY AS FOLLOWS:

- 1. The Authority hereby authorizes a written amendment to the contract for change order #1 for curbside recycling in an amount not to exceed \$8,290,532.58.
- 2. The Certifying Finance Officer has certified that the additional funds are available from the funds of the Authority and the Certifying Finance Officer is hereby authorized to amend the certifications to reflect the above increases.

WHEREAS, a regular meeting of the Middlesex County Improvement Authority (the "Authority") was held on September 14, 2022; and

WHEREAS, pursuant to N.J.S.A. 40:37A-55(t) a County Improvement Authority is empowered to enter into any and all agreements or contracts, execute any and all instruments and do and perform any and all acts or things necessary, convenient or desirable for the purposes of the Authority or to carry out any power given in the County Improvement Authorities Law, N.J.S.A. 40:37A-44 et seq. (the "Act"), subject to the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq.; and

WHEREAS, pursuant to N.J.S.A. 40A:11-11(5), two or more contracting units may establish a Cooperative Pricing System for the provision and performance of goods and services and enter into a cooperative pricing agreement for its administration; and

WHEREAS, the Middlesex Regional Educational Services Commission now known as the Educational Services Commission of New Jersey (the "Commission") has established a voluntary Cooperative Pricing System (the "System") with other contracting units to effect substantial economies in the provision and performance of goods and services; and

WHEREAS, the Authority by Resolution 09-86 duly adopted by the Authority on June 10, 2009, authorized participation in the System and approved a cooperative pricing system agreement (the "Agreement") with the Commission; and

WHEREAS, the Commission has certain products and services included in the System; and

WHEREAS, the Middlesex County Board of Chosen Freeholders on June 2, 1994 adopted Amendment 1994-2 to its Solid Waste Management Plan, which Amendment assigned the implementation responsibilities for the yard waste and curbside recycling programs (the "Programs") for the County of Middlesex to the Authority; and

WHEREAS, in operating the Program, the Authority is in need of certain containers that are available from the System; and

WHEREAS, the Authority would like to authorize the procurement of the recycling containers from the System in accordance with this Resolution.

### NOW, THEREFORE IT IS HEREBY RESOLVED BY THE MEMBERS OF THE MIDDLESEX COUNTY IMPROVEMENT AUTHORITY AS FOLLOWS:

- 1. The Authority hereby approves the purchase of 1,200 32-gallon round recycling containers from TMF Corporation under ESCNJ Contract #22/23-14 for a not to exceed amount of \$22,200.00
- 2. The Authority hereby authorizes the Chairman or Executive Director to execute any purchase orders or documents that may be required to purchase the products from the System.
- 3. The Certifying Finance Officer has certified that the funds for the purchase are available from the funds of the Authority.
