MIDDLESEX COUNTY BOARD OF ELECTIONS PROVISIONAL BALLOT HEARING NOVEMBER 18, 2022

The Provisional Ballot Hearing of the Middlesex County Board of Elections was called to order by Chairman Engel at 4:00 p.m. Flag salute followed.

Chairman Engel announced that the purpose of this meeting is to hear challenges and review and vote on provisional ballots that staff recommended be rejected.

There were a total of 5 provisional ballots for New Brunswick being challenged by Joe Catanese. Mr. Catanese did not attend the meeting. The Board proceeded to review and vote on ballots that staff recommended be rejected.

Commissioner Jalloh joined the meeting. Administrator Lynch indicated that ballots are still being counted. An emergency meeting will be held on Monday, November 21, 2022, at 9:15 a.m. to address any remaining ballots and to certify the election.
