**NOW, THEREFORE**, in consideration of the sum of One (\$1.00) dollar and other good and valuable consideration the **OWNER** herein above referred to does hereby covenant, promise and agree and does hereby dedicate by easement the hereinafter described lands for the purposes as follows;

- 1. There shall not be erected at any time on said lands any building, structures or signs which may in any way interfere with the view or sight of operators of vehicles or pedestrians traversing the abutting driveways, streets, roads or highways. However, such varieties of ground cover or shrubs having an ultimate height of from two to 3.5 feet and that may easily be cared for by the County Road Department may be planted in the area designated below.
- 2. The County of Middlesex, its agents, representatives or employees may, but shall have no duty to enter upon and re-enter upon said lands hereinafter described for the purpose of establishing a clear sight or view for operators of vehicles or pedestrians traversing the abutting driveways, streets, roads or highways.
