In accordance with the Middlesex County Uniform Claims Procedure, and as defined in NJSA 40A:11–2 (6), the County of Middlesex, a municipal corporation of the State of New Jersey, has instituted a policy to enter into agreements for professional services on the basis of demonstrated competence and qualification for the type of professional serviced required by the County, at low and reasonable fees. To this end, MIDDLESEX COUNTY will require the following services in 2025:

C. <u>ENGINEERING SERVICES FOR THE OPEN SPACE AND FARMLAND PRESERVATION PROGRAM.</u>

The County requires engineering services for due diligence functions performed by the County for the Open Space and Farmland Preservation Program. Such engineering Services may include, without limitation, Phase I Environmental Assessments, Phase II Environmental Assessments, wetlands delineation, soil sampling, preparation of bidding documents and contractor monitoring, review of zoning ordinances for purposes of permitted use evaluations and lot analysis, as may relate to an acquisition for the program.
